# Hunt Contract

1. This contract shall be constructed and enforced in accordance with the laws of New Mexico. All parties hereby agree that the proper venue for any litigation concerning this contract shall be New Mexico. The invalidity of any provision of this contract shall not impair the validity of any other provision. In the event that any competent court of law shall determine that there is liability on the part of the **Outfitter** for damages in connection with any provisions of this contract, then and in that event the **Client** agrees that the liability shall not exceed the total amount of the **Hunt** (#4 on Contract), less or minus any and/or all commissions paid to any and/or all booking agents or other agents.
2. **Outfitter** rests on the express condition and agreement that in executing the itinerary and **Hunt**, that he shall not be liable for any injury, loss, damage, accident, delay, irregularity or expense arising out of, or in any way connected to, the use of any vehicle or service, strikes, wars, weather, acts of God, quarantine, sickness, government regulations or restrictions or from any net or omission of any enterprise, hotel, airlines or any other organization, individual or agency or for any other cause in connection herewithin. All services are subject to the laws of the country visited. **Outfitter** is not responsible in any way for loss or damage to luggage or any personal effects, including weapons. **Outfitter** shall provide the services as outlined in the **Hunt Description** (#3 on Contract) and as stated on that Contract and **Outfitter** further agrees to notify **Client** 14 (fourteen) days in advance of the **Commencement Date of Hunt** of any changes in the **Hunt Description**, excluding those changes caused by weather or other natural acts of God. **Outfitter** shall employ qualified and competent guides or assistant guides for the **Client** in executing the **Hunt** and provide reliable and up-to-date equipment for their use while executing the **Hunt**. **Outfitter** agrees that all animals legally taken by the **Client** will be field dressed, and the hides, horns or antlers properly prepared for shipping to a Taxidermist. **Outfitter** reserves the right to withdraw the **Hunt** or any part thereof, to make such alterations in the itinerary as are necessary or desirable. If the **Outfitter** withdraws the **Hunt** or any part thereof, the **Outfitter** will be responsible for making the full or partial refund to the **Client**. **Outfitter** further reserves the right to refuse or retain as a member of the **Hunt** any person at any time (for just cause) and to pass on to the **Hunt** members or **Client** any documented expenditures occasioned by delays or events beyond the **Outfitters** control.
3. **Client** represents and warrants to **Outfitter** that his/her physical and mental condition is such that he/she is capable of competently embarking on the **Hunt**. **Client** acknowledges that expeditions to wilderness areas for the purpose of hunting, photo safaris, hiking or adventure travel is of a dangerous nature and that the use of hunting weapons is inherently dangerous. Nevertheless, the **Client** hereby assumes the risk of any injury which should occur during the travel and **Hunt** and holds the **Outfitter**, their officers, agents and employees, harmless from any liability resulting from any illness, accident, injury, death or loss of any nature arising out of the activities provided hereto. **Client** shall bear any and all emergency evacuation and medical expenses. **Client** shall bear all expenses and full responsibility of shipping and crating of hides, horns and antlers to a Taxidermist as well as all meat processing and meat transportation expenses and responsibility to **Client's** home, or to Mesa, AZ if **Client** chooses not to take all meat home. **Outfitter** agrees to transport meat from the hunting camp to the Depart and Return To point within New Mexico (see #3 on Contract). **Client** shall also bear the cost of hunting licenses, big game licenses, accommodations and meals before and after the **Hunt** and transportation to hunting camp unless stated otherwise on this contract. **Client** further agrees that he will follow standard hunter safety practices and shall be responsible for learning and following all applicable laws and **Hunt** regulations of New Mexico.
4. **Client** understands and further agrees that his/her **Hunt** may be videotaped or photographed by the **Outfitter** and/or his employees. **Client** releases to the **Outfitter** all rights to use said video footage, as well as photographs taken by the **Outfitter** and/or his employees, for promotional purposes for no additional compensation. Also, it is understood that **Outfitter** retains all copyrights to the footage and photographs and all video footage and photographs taken by the **Outfitter** and/or his employees remains the sole property of the **Outfitter**. The **Client** may not reproduce or use such said video footage or photographs for commercial purposes without the express, written permission of the **Outfitter**. The **Outfitter** agrees to provide a free copy of said video and/or digital photos of the **Hunt** to the **Client**.

5. **PAYMENTS, BALANCES & CANCELLATIONS:** **Outfitter** fully appreciates, understands and respects that **Client's Hunt** is a big investment in time, resources and energy and as such **Outfitter** strongly recommends that the **Client** obtain, at their own cost, Trip Cancellation "cancel for any reason" Travel Insurance to cover the total cost of the **Hunt**, including all payments due to the **Outfitter**, in the event **Client's Hunt** needs to be cancelled for any reason whatsoever. Due to the nature of events unforeseen by any, that could occur at any time, it is therefore HIGHLY recommend **Client** purchase travel insurance with "cancel for any reason" trip cancellation insurance, as well as possibly a membership and/or insurance for medical advisory and/or evacuation, or similar type evacuation insurance. For guidance on these travel protection services and to enroll, contact [www.globalrescue.com](http://www.globalrescue.com) or another similar type travel insurance company that you could purchase insurance through. Typically these types of travel insurance policies must be purchased within 14 to 20 days of when the hunt is initially booked and the initial payment is paid to **Outfitter** so again it is strongly recommend **Hunter** invest in "cancel for any reason" trip cancellation insurance for the cost of your **Hunt**, and any payments made by **Hunter** to **Outfitter** towards **Hunt**, cannot, and will not, be refunded by **Outfitter** for any reasons that are not directly within **Outfitter's** control. **Client** agrees initial **Hunt** payment (#4 on Contract) is required in full six (6) months in advance of commencement of hunt or at time of booking, whichever occurs first, and **Client** agrees remaining balance of hunt (#4 on Contract) is required, in full, on or before July 1st of the year the **Hunt** is to commence. In the case of spring bear hunts, the remaining balance of hunt (#4 on Contract) is required, in full, on or before February 1st of the year the **Hunt** is to commence. **Client** will not be permitted to begin **Hunt** until full payment has been received by **Outfitter**. If the **Client** cancels the **Hunt**, or the **Hunt** is forced to be canceled, outside of the control of the **Outfitter**, due to strikes, wars, weather, acts of God, pandemics, quarantine, sickness, government regulations, mandates, restrictions or from any net or omission of any enterprise, hotel, airlines or any other organization, individual or agency or for any other cause during the period of less than 180 days prior to the **Commencement Date of Hunt**, the **Client** shall not be entitled to a refund, however **Hunt** payments, though not refundable, may be transferred to a different **Client / Hunter** for the same contracted **Hunt**, in the same calendar year, if the **Outfitter** is notified of such changes in writing by the **Client** 30 days or more before the **Commencement Date of Contracted Hunt** and provided **Hunt** is not restricted by any state or federal law, regulation, mandate or other prohibition and is allowed to commence as agreed upon in this Hunt Contract. If the **Client** cancels the **Hunt** during the period of more than 180 days prior to the **Commencement Date of Hunt** the **Client** shall receive a full refund of the initial payment(s) paid to the date of cancellation (#4 on Contract), less or minus a \$2,000.00 service charge and less or minus any and/or all commissions paid to any and/or all booking agents or other agents by the **Outfitter** or **Client**. **Outfitter** must be notified by registered mail of any cancellations or changes. Any hunts and/or amounts to be transferred to another **Client / Hunter** must be with the written approval of the **Outfitter**.

6. **General Agreements:** This contract supersedes any and all previous agreements and understandings, whether verbal or written and constitutes entire agreement and understanding between the **Outfitter** and **Client** with respect to the subject matter hereof. A photot or facsimile of this contract shall be considered a legal document by all parties. This contract is not assignable to another party without written consent of the **Outfitter**. This contract shall inure to the benefit of and be binding upon the parties hereto only.
